RETAINER AND PAYMENT REQUIREMENTS: To reserve the date, photographer requires a retainer of \$500. Photographer will not hold any date open without receipt of said retainer. Said retainer is non-refundable for any reason, except if this agreement cancelled by Photographer. The remaining balance of \$_____ must be received by photographer no later than one (1) month prior to the event date.

WEDDING DATE CHANGE: If it is required that your date be moved for any reason, please notify Photographer within 48 hours to discuss availability. Photographer will allow one (1) date change with no financial penalty.

COOPERATION: The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. Photographer recommends that Client designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed. Photographer will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for photographs. Photographer is not responsible if key individuals fail to appear or cooperate during photographs or for missed images due to details not revealed to Photographer.

OWNERSHIP RIGHTS AND RESPONSIBILITIES: Photographer and Client agree that unless stated otherwise in this document, Photographer owns any and all copy or reproduction rights. Client agrees to not reproduce or copy any books/albums or other photograph of the event, developed by Photographer, without Photographer's written permission. Client provided DVD from Photographer has unlimited reproduction and/or duplication rights upon receipt of the same. Photographer will provide Client with a "copyright release" letter.

COMPLETION SCHEDULE: Digital editing shall require up to 4 weeks to complete. Online proofing will be available at this time. Signature Photo Journal albums require an additional weeks from the completion of digital editing.

LIMIT OF LIABILITY: Photographer warrants and declares that every effort will be made to provide high quality photographic services. In the unlikely event that a catastrophic mechanical failure should occur to Photographer's equipment and Photographer is unable to provide Client with the agreed upon photography services and/or products, Photographer agrees to reimburse Client for all amounts paid to date. Photographer and Client agree that Photographer is not responsible for any other damages, emotional or otherwise.

Client(s) agrees that Photographer may use any photograph for publicity purposes that he chooses that contain images from the event. Such publicity and advertising may include publication on Photographer's Internet Website.

HOUSE RULES: The photographer is limited by the guidelines of the ceremony official or reception site management. Client agrees to accept the technical results of their imposition on the Photographer. Negotiation with the officials for moderation of guidelines is Client's responsibility; Lucky Pro Photography will offer technical recommendations only.
